Executive Summary

This document organizes the current Craig W. Hagin research file into one chronological timeline by date, not by category.

The confirmed spine includes Hagin ministry legacy history, Craig Hagin's birth and education, first marriage and divorce records, children from the first marriage, ministry roles, documented public travel, public political-network overlap with Jackson Lahmeyer, property-record leads, criminal/legal public reporting, and Rhema's June 3, 2026 termination of Craig's employment and ministry association.

The document also preserves serious user-reported concerns as leads only. Those include alleged vehicle-title concerns, alleged sexual misconduct reports, alleged institutional-response concerns, alleged harassment/fake profiles, and alleged travel/relationship overlap involving Elizabeth Dalton / Elizabeth Peasley. These are not stated as proven facts.

Craig Wayne Hagin was born into an already-established multigenerational ministry system connected to Kenneth E. Hagin, Kenneth W. Hagin, Kenneth Hagin Ministries, Rhema Bible Training College, and Rhema Bible Church.

His confirmed timeline includes a 1991 marriage to Melissa Lynn Robertson, three children, a 2005 divorce, a 2006 remarriage, decades of public Rhema/KHM ministry roles, international ministry travel by at least 2015, political/ministry-network overlap with Jackson Lahmeyer, and a series of public legal and institutional issues in 2026.

Publicly documented legal items include the 2004-2005 divorce case, a 2026 animal-cruelty arrest and pending criminal case, a 2026 Rhema employment/leadership termination, a reported foreclosure, and an approximately \$36,000 tax lien/garnishment lead requiring direct docket/lien verification.

2017 - Blake Kenneth Hagin drive-by shooting case

- Blake Kenneth Hagin, Craig's son and a Hagin family descendant, was charged in connection with a March 2017 drive-by shooting in Broken Arrow.

2020-2023 - Public social-media interaction with Beth Dalton / Elizabeth Peasley

Status: Social-media overlap only

Evidence / source note: Uploaded Beth overlap timeline.

- Public indexing shows Craig Hagin appearing on or interacting with Beth Dalton / Elizabeth Peasley real estate-related posts.
- This supports social-media connection, not travel, relationship status, or physical presence together.

2021 - Craig receives Doctor of Ministry degree

Status: Confirmed biography item

Evidence / source note: Uploaded Craig/Hagin timeline.

- Craig Hagin's ministry biography states he received a Doctor of Ministry degree from the School of Bible Theology Seminary & University in San Jacinto, California, in 2021.

April 16-17, 2021 - Broken Arrow, Oklahoma - Health and Freedom Conference

Status: Confirmed local appearance

Evidence / source note: Uploaded travel timeline.

- Craig Hagin was listed as a speaker at the Health and Freedom Conference connected to the Rhema campus.
- Travel note: local event.

July 23, 2021 - South Tulsa property quitclaim deed

Status: Property record lead / needs deed image

Evidence / source note: User-provided property analysis.

- Property record lead reportedly shows Grantor: Hagin Craig W.; Grantee: Hagin Craig W. & Mia M.; Sale price: \$0; Deed type: Quit Claim Deed.
- Interpretation: likely not a true market sale; a \$0 quitclaim deed often indicates title/ownership restructuring, adding a spouse, estate planning, title cleanup, or asset organization.

August 1-2, 2021 - 123 Miracle Conference

Status: Strong lead

- A listing referenced Craig Hagin as a special guest at 7 p.m. with Rev. Dr. Lanre and Dr. Liz Smith.
- Missing: city, state, venue, and host church address.

October 30, 2021 - Jackson Lahmeyer publicly describes Craig as “closer than a brother”

- Jackson Lahmeyer publicly stated Craig had been a friend “closer than a brother.”
- The post also stated they had traveled across the U.S. together and said, “we need more pastors like Craig.”
- This is an important Craig/Jackson political-ministry network marker.

2022 - Moundville, Alabama - Alabama Aflame 2022

Status: Confirmed / strong host-church lead

Evidence / source note: Uploaded travel timeline.

- Craig was listed as featured speaker for Alabama Aflame 2022 at Dominion Church.
- Needs preserved screenshot/source capture for publication.

2022 - Alleged Jackson Lahmeyer relationship/adultery concern involving Caitlin Simmons Key

Status: Separate Jackson timeline item / not Craig fact unless Craig-specific source exists

Evidence / source note: Uploaded Caitlyn/Sheridan files.

- User-provided materials include screenshots and notes relating to Caitlin Simmons Key and Jackson Lahmeyer.

- Craig was shown preaching at Rhema Bible Church.
- Travel note: local Rhema event.

June 17, 2024 - Las Vegas, Nevada

- Craig posted about his flight to Vegas.

December 8, 2024 - Yuba City / Marysville, California lead

Status: Strong geographic overlap lead; not confirmed joint travel

Evidence / source note: Uploaded Beth overlap timeline and public Facebook travel pull.

- Craig publicly posted about spending time with Rudy Giuliani, and indexing referenced Yuba City/Marysville, California.
- Public indexing separately connects Elizabeth Peasley's household/family location to Yuba City, California.
- This creates a geographic overlap lead, but it does not prove Beth/Elizabeth traveled with Craig or attended the same event.
- Needed proof: photo, tag, check-in, caption, or comment naming both at the same event/location/date.

December 24, 2024 - Broken Arrow, Oklahoma

Status: Strong social-media lead

Evidence / source note: Uploaded travel timeline.

- Indexed social media result references Craig posting about a Christmas Eve service at Rhema Bible Church.
- Travel note: local event.

January 2025 - Washington, D.C.

Status: Confirmed public Facebook travel lead

Evidence / source note: Uploaded public Facebook travel pull.

- Craig posted that he was starting his journey to Washington, D.C.
- Political/event context lead.

January 21, 2025 - Washington, D.C. - Multicultural Ball

Status: Confirmed public Facebook political-event lead

Evidence / source note: Uploaded public Facebook travel pull.

- Craig posted that he had a great time in D.C. at the Multicultural Ball.
- This appears connected to inauguration-week political events.

February 18, 2025 - Tulsa, Oklahoma - Eric Trump luncheon promotion

Status: Confirmed Craig/Jackson public political lead

Evidence / source note: Uploaded public Facebook travel pull.

- Craig publicly posted that Jackson Rhodes Lahmeyer and himself were bringing Eric Trump back to Tulsa for a luncheon on March 6.
- This directly ties Craig and Jackson Lahmeyer to a Tulsa political event.

March 6, 2025 - Tulsa, Oklahoma - Eric Trump luncheon

Status: Event lead from Craig's February post

Evidence / source note: Uploaded public Facebook travel pull.

- Craig's February 18 post promoted an Eric Trump luncheon in Tulsa scheduled for March 6.
- Preserve event flyer, registration page, or post screenshot for final documentation.

June 2025 - Lagos, Nigeria - Rhema Conference

Status: Confirmed public Facebook / Rhema Nigeria lead

Evidence / source note: Uploaded travel timeline.

- Craig posted that his Saturday night outfit was worn at Rhema Conference in Lagos.

- Rhema Nigeria also publicly welcomed Craig to Lagos for Rhema Conference 2025.

June 2025 - Port Harcourt, Nigeria

Status: Strong lead

Evidence / source note: Uploaded travel timeline.

- Rhema Nigeria posts and indexed social results connect Craig to Rhema Conference 2025 activity involving Port Harcourt.
- Needs screenshot/archive capture.

June 27-29, 2025 - Lagos, Nigeria - Faith Conference

Status: Strong event lead

Evidence / source note: Uploaded travel timeline.

- Global Harvest Church Island public result shows Faith Conference dated June 27-29, 2025 naming Craig Hagin and Pastor Isaac Oyedepo.
- Needs screenshot/archive capture.

June 30-July 5, 2025 - Abuja, Nigeria - Rhema Conference Abuja/
Nasarawa

Status: Confirmed public Rhema Nigeria lead

Evidence / source note: Uploaded travel timeline.

- Craig was tied to Rhema Conference Abuja/Nasarawa.

July 1-7, 2025 - Abuja, Nigeria - COZA 7 Days of Glory

- Craig was listed as a speaker for COZA 7 Days of Glory 2025.

- Needs screenshot to confirm physical attendance.

Status: Confirmed public Facebook travel/speaking lead

Evidence / source note: Uploaded public Facebook travel pull.

- Craig posted he was headed to Sioux Falls, South Dakota, to preach that Sunday.
- Indexed result says he was traveling from Tulsa International Airport.

Status: Confirmed travel lead, not speaking yet

Evidence / source note: Uploaded public Facebook travel pull.

- Craig posted he was speaking November 16 in Plant City, Florida, in both morning and evening services.

March 19-20, 2026 - Animal-cruelty investigation and arrest

Status: Confirmed public reporting / pending criminal case

Evidence / source note: Uploaded criminal/legal timeline and public reporting summary. Craig was arrested around 8:00 pm on March 19th, 2026. He was bonded out around 10:00 am in the morning when his 80-year-old father Pastor Kenneth Hagin of Rhema Bible Church went and paid to get him out. They both left the jail leaving Mia behind in the jail. Craig reported directly to me that his parents Kenneth and Lynette Hagin refused to bail Mia out. Mia was there for approximately another 10 hours after Craig was bailed out. Her sister Missy was out of the country at the time of the arrest.

- Do not describe Craig as convicted unless a court record confirms conviction or plea.

- Public reporting identified Craig Hagin as a co-pastor of Rhema Bible Church.
- Reporting also identified him as connected to Rhema Bible Training College and Kenneth Hagin Ministries.
- A Rhema/KHM spokesperson reportedly confirmed Craig stepped down from his church position and roles as instructor and COO while the matter was being addressed.

June 3, 2026 - Rhema ends Craig Hagin's employment and ministry association

Status: Confirmed official/public reporting

Evidence / source note: Uploaded timeline and public reporting summary.

- **Rhema Bible Church stated Craig Hagin’s employment, leadership roles, and association with Rhema Bible Church and its ministries ended effective June 3, 2026.**
- Rhema stated he was no longer authorized to serve, speak, or act on behalf of Rhema.
- Public reporting said Rhema described the action as based on separate and credible information regarding conduct inconsistent with ministry leadership standards.

Mia found out and called Blake to see if he would go see if the car was there. Blake told Lynette Hagin and she wanted to go look too. They found the car and had Craig come and move the car. The car was moved and eventually Craig allowed Mia to drive him, stating he was upside down on the car and could not sell it. Mia then became in possession of the car and the registration.
